

**Resolution to Call for the Resignation of Nick Myers and the Credentials Committee Over the RNC
filing to negate the Missouri Republican State Convention**

Whereas the single most important event in the current term of the Missouri Republican State Committee is the Missouri Republican State Convention

Whereas per the Republican Party, the Missouri Republican State Convention is the highest authority for Republicans in the State of Missouri

Whereas official badges were missing from Missouri State Delegates from Congressional District One and Congressional District Six even though the data was properly turned in by the counties affected and the information was present on the sign-in sheets

Whereas the credentials committee failed to execute the electronic credentialing they intended to use, and the Missouri Republican State Convention had to switch to a manual credentialing process which resulted in a five hour delay in the start of the Missouri Republican State Convention

Whereas none of the 849 Missouri Delegates on the floor of the Missouri State Republican Convention objected to the official credentials report generated through the manual process that was performed and the credentials report was unanimously passed

Whereas the temporary chair of the Missouri Republican State Committee Chairman, Nick Myers, was unable to retain effective control of the temporary chair portion of the convention and needed to pass control to Parliamentarian Chris Howard who demonstrated better control

Whereas Nick Myers withdrew his 16-person Chairman's slate effectively preventing his 11-person slate from being able to compete against the Truly Grassroots Slate for Trump slate in the 30-minutes and then additional 15-minutes allotted, which resulted in forfeiture of his slates

Whereas quorum was never questioned until after the 2024 Missouri State Republican Platform's 27th Amendment was passed yet the state opted to reject the work done at the Missouri State Republican Convention on the platform instead of accepting the work performed before quorum was found to be lost

Whereas the entire Missouri State Republican Convention was recorded on video and there is video proof of the activities that were performed, and motions passed, along with the fact that Jodi Widhalm, the permanent official Secretary of the Missouri State Republican Convention, took the minutes that no one disputes

Whereas, according to the Republican National Convention has reported that they never received the proper delegate information from the Missouri State Republican Committee even though the credentials report was accepted by a unanimous vote of the Missouri Delegates at the Missouri Republican State Convention and the Missouri State Republican Committee stated they lost the data

Whereas after the Derrick Good (Jefferson County) and Dan O'Sullivan Junior (Saint Louis County) challenges were accepted by the RNC based on the fact that the proper delegate information from the Missouri State Republican Committee was never properly filed, thus negating the results of the entire Missouri Republican State Convention and the hard work of the 849 delegates in attendance, along with effectively wasting all travel costs associated with everyone who attended the Missouri Republican State

Convention, including guests, as well as wasting all costs associated with putting on the convention paid for by the Missouri Republican State Convention and donors

Whereas the negating of the results of the Missouri State Republican Convention disenfranchised the voices of the 849 delegates in attendance who attended on good faith

Whereas during the Missouri Republican State Committee meeting held on June 8, 2024 Nick Myers admitted fault for the results of the convention and told everyone in attendance he takes responsibility for the failures from the 2024 Missouri State Republican Convention

We, the Republican Party City of St. Louis Central Committee urge Nick Myers, who is ultimately responsible for the Missouri Republican State Convention to resign immediately

In addition, we urge entire credentials committee who were involved with credentialing process of the 2024 Missouri State Republican Convention and caused the excessive delay to the start of the Missouri State Republican Convention as a result of the failure to implement their electronic credentialing, as per their plan, resulting in the requirement to go manual, as well as failure to include pre-printed badges for ALL Missouri Delegates who attended the Missouri State Republican Convention even though the information from each county was properly turned in to resign immediately

In addition, somewhere between both Nick Myers and the Missouri State Republican Convention Credentials Committee resulted in not filling the proper paperwork concerning the Missouri State Republican Convention to the Republican National Convention, even though all 115 Missouri counties provided this information, per the rules of the individual May 2, 2024 caucus the above should also resign for a minimum of demonstrating gross incompetence.

Due to the fact that there are only a few months left of the current Missouri State Republican Committee term, we request these individuals also be ineligible to hold any seat on the Missouri State Republican Committee for the next term.

If the above people do not voluntarily resign of their own accord, then we request that the Missouri State Republican Committee members call a vote to have the Missouri State Republican Committee members vote them out by the 2/3rds vote required per Missouri Statute 115.624 for a minimum charge of gross incompetence.
